



MANAGER'S COMMENT

The Edge RCIS Matador Retail Hedge Fund returned 2.13% for October, relative to the SWIX index return of 2.64%. This brings the Fund's YTD return to 7.4%, relative to the benchmark's return of 7.1%.

The FTSE/JSE All Share (ALSI) increased by 3.14% on a total return basis as at 31 October 2019, whilst the All Bond Index decreased by -0.35%, and STEFI returned 0.59%. The JSETop 40 index increased by 2.96%, Mid-Caps increased by 7.19%, and Small Caps increased by 1.74% during the month. The best sector performance of local equities was in the Gold sector (+22.04%) and Pharmaceuticals (+19.15%). The worst performing sectors were Beverages (-11.76%) and Software (-6.14%). Local equities had a very good month as global risk appetite increased. The good performance was across the board, with healthcare, basic materials and consumer services leading the way. Technology (Naspers), ended down for the month, while beverages (Anheuser-Busch), were sharply down on company specific news. Non-residents sold off R21.9bn worth of SA equities in October. In the SA bond market, non-residents were net buyers of local bonds, with the R4,8bn inflow in October offsetting September's R2,6bn outflow.

From an attribution perspective, both the directional long/short and alpha managers contributed positively to performance. Long positions in gold and platinum companies did exceptionally well, whilst global rand-hedge shares (Naspers, Prosus and Anheuser-Busch), detracted the most from performance. At month-end, we increased the exposure to our long/short managers after a client inflow.

Trade disputes and geopolitical frictions have become key drivers of the economy and markets. US trade policy is increasingly unpredictable. Persistent uncertainty from protectionist policies is denting corporate confidence, and slowing business spending. Yet the global economic expansion remains intact, supported by dovish central banks and a robust US consumer. This suggest moderate risk-taking will likely be rewarded.

INVESTMENT MANDATE

The portfolio may invest in the participatory interests of hedge fund portfolios in any retail investor collective investment scheme; in any other securities (including, without limitation, derivative instruments), financial products and assets, subject only to the requirements of the Act read with the Hedge Fund Requirements. The Portfolio is permitted to invest in offshore investments. The Portfolio may invest in other portfolios of The RCIS Retail Hedge Fund, provided that neither the Manager nor the Investment Manager accrues fees in respect of such investment by the Portfolio in such RCIS Retail Hedge Fund. The Manager may create leverage in the Portfolio by borrowing funds, using short positions or engaging in derivative transactions.

INVESTMENT OBJECTIVE

The objective is to identify and invest in a combination of underlying funds whose mandate is to seek out absolute returns. Whilst it is envisaged that the underlying funds will be predominately established and domiciled in South Africa, the Portfolio may, from time to time, subject to applicable exchange control regulations, invest in funds established and domiciled outside South Africa, where in the opinion of the Investment Manager, such funds will ultimately enhance the absolute return of the Portfolio.

Medium: These portfolios generally hold more equity exposure than low risk portfolios but less than high risk portfolios.
